## National Chengchi University Course Selection Guidelines for College English Curriculum

(revision approved by 2015 Academic Year 1st Semester 1st Academic Affairs Meeting on October 26, 2015)

Article 4 Students who meet the exemption standards should satisfy the General Education Foreign Language requirement with either courses in ONE second foreign language (the same language for one academic year, or two semesters) or EMI (English as a medium of instruction), shown on the course-selection system). For students who meet the exemption standards, credits earned from College English I, II, III will NOT satisfy the General Education Foreign Language requirement.
